

# GOLF CART RULES AND REGULATIONS

- ❖ Golf carts and ATV's may be used by CCCC members in good standing. They may only be used on already established roads at CCCC.
- ❖ **SPEED LIMIT on CCCC property is 10 MPH at all times.**
- ❖ No cart storage is available at the club. Bring cart with you and take home same day of use. \*(see camper rule exemption)
- ❖ 1 cart per member
- ❖ Cart owners are responsible for the actions of family/friends on said vehicle on club property. Same rules and penalties apply.
- ❖ No charging of carts in range area (charging and storage not available, at this time).
- ❖ NO CARS OR TRUCKS ALLOWED ON RANGE PATH.
- ❖ All golf carts will be in good working condition. Gasoline-powered carts must have a muffler silencer in place and shall not emit excessive noise or smoke.
- ❖ **Use of golf carts on the ranges for target changes is limited to handicapped members only. Only carts designed for off-road use will be allowed on the ranges. (We do not want anyone getting stuck or hurt downrange)**
- ❖ Handicap CCCC members using a cart on range must display or have on hand at their target bench a current handicap tag in their name.
- ❖ Cart paths will be identified and follow along the right side of the 100 yard and 200/300 yard range.
- ❖ Owners are responsible for any personal injury or property damage caused by golf cart operation. CCCC assumes no liability for accidents, misuse, theft, damage, injury or any other occurrence or mishap arising from golf cart operation on CCCC property.

- ❖ Golf carts may not be operated by unlicensed drivers, unless accompanied by a parent/guardian. Children under the age of 14 shall not operate golf carts at any time on club premises.
- ❖ Anyone operating a golf cart on CCCC property must produce a valid ID upon request.
- ❖ Golf carts may NOT carry more than the number of passengers for which they were designed.
- ❖ Golf cart operation is limited to use on established club roads and gun-range path only. (Except for CCCC Board pre-approved work-details)
- ❖ Operators must observe safe driving practices. Excessive speed and unsafe maneuvers will not be tolerated.
- ❖ **SPEED LIMIT on CCCC property is 10 MPH at all times.**
- ❖ **ADHERE TO ALL RANGE RULES.**
- ❖ While using cart on range, **STAY ON CART PATH.** (Off range-path violations face same penalties as speeding)
- ❖ \*Storage exemption for permanent campers; (permanent campers may store no more than (1) golf cart/atv at their site. Camper assumes all responsibility for said vehicle.)

### **PENALTIES for Violations:**

**1<sup>st</sup> Violation- Verbal Warning**

**2<sup>nd</sup> Violation- Cart privileges REVOKED**

**The board of trustees has approved these rules on a 1 year provisional basis. Please respect these simple rules as multiple violations may force the board to suspend/revoke these privileges for everyone.**
