

## CROOKED CREEK CONSERVATION CLUB RULES OF CONDUCT

\*\*\*\*\*

On occasion, some members have inadvertently found themselves doing certain things that are in conflict with the best interests of your club. To help prevent such embarrassments, the Board of Trustees has approved the following rules that pertain to the club grounds.

1. Each member is required to carry and to show a current membership card when requested to do so by another member.
2. The Board may close the road when deemed necessary because of its condition or for other reasons. At such temporary times, the road will be posted and the gate's combination will be changed.
3. All personal vehicles are to be driven over club roads and recognized parking areas only. Vehicles are prohibited beyond the camping and orchard area. The **SPEED LIMIT is 10 MPH.**
4. Vandalism will not be tolerated. Members are responsible for the actions of family members and guests. Members are urged to report vandal's license numbers and vehicle descriptions.
5. Don't be a litterbug. Members are required to clean up an area after use.
6. Crops grown on club property are to be used on the property unless otherwise approved by the Board. 'Crops' to mean corn, pumpkins and other planted flora. Trees, including Christmas trees, are the exception and are not to be disturbed.
7. Firewood is restricted to fallen timber unless otherwise approved by the Board. Use of firewood is restricted to club property.
8. Open fires are allowed only in fire rings in approved areas or portable grills.
9. Picnic tables are not to be moved for use to location other than the picnic, clubhouse and pavilion areas. These tables are for the members use in picnic areas only.
10. Camping will be restricted to designated areas only.
11. The use of the shooting ranges, including the dog training areas, is **RESERVED FOR MEMBERS ONLY.** Guests will be allowed to shoot over the ranges one time upon the written permission of a Trustee. The shooting guest must have such permission available for inspection by any club member. This rule does not apply to club scheduled shooting events.
12. The Board may suspend all shooting should same be in conflict with scheduled events including work parties.
13. Shooting at clay targets is restricted to the **TRAP** and **SKEET** ranges. Shooting at glass targets is prohibited. Other targets must be picked up and disposed of properly, including target frames. A dumpster is outside of the club gate for your use.
14. Automatic weapons and devices that will permit semi-automatic weapons to fire automatically are banned from the ranges and club grounds.
15. No alcoholic beverages are permitted on shooting ranges, prior to hunting, while hunting or handling firearms or archery equipment.
16. Hunting of game during appropriate seasons is **RESERVED FOR MEMBERS ONLY.** There are no quest privileges available. Anyone hunting must follow all Ohio game laws and possession limits. No Sunday hunting is allowed East of the swale and old duck pond. No waterfowl hunting on the main pond.
17. **NO SWIMMING** is allowed in the lake.
18. Use of live minnows is prohibited in the lake.
19. Bass less than 12 inches shall be considered undersize and must be released. The Board requests you practice "Catch and Release"

Any infraction of the above rules and rules of good sportsmanship may be cause for revoking of membership and/or other disciplinary action. Considering the varied uses of the club grounds available to the membership, these rules are really few in number. These rules only emphasize specific points, in most instances, common sense should tell us how we should be able to enjoy our club.
